Faith Formation: A Condition for Employment

Catholic education is a ministry of the Church and its primary purpose is to bring the joy of the Gospel to the young people whom we serve. Therefore, the Office of Catholic Schools of the Archdiocese of Hartford adopted a faith formation policy as a condition for employment for all educators of Catholic schools in the Archdiocese of Hartford.



Policy 3.202 of the *Handbook of Policies and Procedures for Catholic Schools* states: Full-time teachers except high school teachers of religion and campus ministers shall have or obtain a certificate of completion in a faith formation program or its equivalent as determined and approved by the Office of Catholic Schools, within five years of commencement of employment. Individuals who do not complete the program within the allotted time may be terminated.

You may be exempt if...

- You have a bachelor's degree or higher in theology or its equivalent from a regionally accredited Catholic university
- You attended a Catholic university: any theology courses you took that directly correspond to the faith formation requirements or if you begin work on a Masters in Theology from an accredited Catholic college or university and take courses that directly correspond to the VLCFF or STEP courses listed

The policy states the coursework must be completed in the **first five years of full-time employment**. If, for any reason, you encounter extenuating circumstances that prevent you from completing all six courses, you may be eligible for an extension.
