Those who already applied to fly with the Pope through the Vatican, must also apply through our application process in order to get an accreditation for the activities organized by the National Commission. Both applications are independent, but the information will be crossed.

This application allows to cover the following places:

- 2. Nunciatura Apostólica (outisde)
- 3. Plaza de Armas (Metropolitan Cathedral)
- 4. Misa Parque O'Higgins
- 5. Santuario Nacional de Maipú
- 6. Aeropuerto de Temuco
- 7. Misa Maquehue
- 8. Aeropuerto de Iquique
- 9. Misa Playa Lobito

The Media Organization or individual could choose one activity or all of them. However, the Commission will apply a selection criterion, based in space availability, and plurality of the Media participant. After the selection has been made, you will receive an email with the acceptance, and the specific activities where you could participate. Also, we will require two extra documents:

- 10. Media letter
- 11. Passport copy

The accreditation for the follow activities: Santuario Padre Alberto Hurtado y de la Pontificia Universidad Católica de Chile, will be responsibility of each organization.

In case a professional already accredited no longer work in the Media Organization provided in the application. Who must inform us will be it Media Director.

Each credential is personal, unstranferable, and it will be only valid in the assigned places.

There will be a plataform exclusively for cameramen and photographers. The rest of team member will be allocated in another available space.

Member of the International Press will have access to a Press Center in each Mass (Parque O'Higgins, Base Área Maquehue y Playa Lobito)
